What Was Paul's Thorn In The Flesh — Chapter 5 (condensed) from "Overcoming Roadblocks to Healing"

here are other hindrances to healing that we need to avoid mentioned in the Bible. These pitfalls in our lives can prevent healing from flowing freely. A belief in physical suffering can also stop healing.

"and lest I should be exalted above measure by the abundance of the revelations, a thorn in the flesh was given to me, a messenger of Satan to buffet me, lest I be exalted above measure. Concerning this thing I pleaded with the Lord three times that it might depart from me. And He said to me, 'My grace is sufficient for you, for My strength is made perfect in weakness.' Therefore most gladly I will rather boast in my infirmities, that the power of Christ may rest upon me. Therefore I take pleasure in infirmities, in reproach, in needs in persecutions, in distress, for Christ's sake. For when I am weak, then I am strong" (2 Corinthians 12:7-10).

There has been a lot of controversy in Christian circles over these scriptures, concerning Paul's thorn in the flesh. Many feel that we have to remain sick to glorify God in our physical weakness. Much of that belief comes from the influence of Greek philosophy and asceticism (a belief in suffering physically to get closer to God) mixed with Christianity in the early days of Christianity. Many have gone to premature graves because of this incorrect belief. In this chapter, we want to share through God's word, exactly what Paul's thorn in the flesh was.

What Religious Tradition Believes Paul's Thorn Was

In 2 Corinthians chapter 12, Paul received a thorn in the flesh as a result of the revelation he saw. Many feel they have received a thorn in the flesh as well. Have they received a revelation so great and been caught up to Heaven as Paul was? This is what brought on the thorn in the flesh (2 Corinthians 12:1-6).

A number of people believe that Paul's thorn was a sickness. Some believe that Paul's thorn was an eye disease that the Lord refused to heal. If that was the case, then Paul was the first person in the New Testament who the Lord refused to heal. Acts 10:38 says, "God anointed Jesus of Nazareth with the Holy Ghost and power, who went about doing good and healing all who were oppressed by the devil, for God was with Him." Only once in the New Testament Jesus was unable to heal the sick: Matthew 13:58, "He did not many mighty works because of their unbelief."

People quote Galatians 4:13-15, to prove that Paul's thorn in the flesh was an eye disease. It reads: "You know that because of physical infirmity I preached the gospel to you at first. And my trial which was in my flesh you did not despise or reject, but you received me as an angel of God even as Christ Jesus. What then was the blessing you enjoyed? For I bear you witness that, if possible, you would have plucked out your own eyes and given them to me." The word infirmity in the original Greek means bodily infirmity, such as mentioned in 2 Corinthians

11:23-30, not a disease. Paul had been physically beaten many times for preaching the gospel and suffered with physical infirmities because of it. However, I am sure God healed him each time, as He does today. The Lord even raised Paul from the dead in Acts 14:19-21. Galatians 4:15 in no way shows that Paul had an eye disease. The Galatians were friendly with Paul at that time and would have given Paul anything he needed, hence Paul writes that you would have given me your eyes if I had needed them. It does not say that he had an eye disease. Paul was merely using that as an example, saying that the Galatians were really committed to him and cared deeply for him and his needs to be met. There is no mention of any eye disease in these

For the sake of argument, let's assume that Paul did have an eye disease and that was the reason why the power of God rested on him. If that was the case, we should all pray and ask God to make us sick so we can be greatly anointed. We should not go to a doctor, but suffer in our sickness to glorify God as well. That is absurd, but that is the way many Christians believe because of the Greek influence, gnosticism and asceticism that was mingled with early Christianity.

After reading what the Word of God says on healing, how healing was provided in the atonement at Calvary, I do not see how anyone could believe that remaining sick glorifies God. John 6:2 says, "Then a great multitude followed Him (Jesus), Because they saw His signs which He performed on those who were diseased." Acts 3-5 tells us that many thousands turned to Jesus because of the miraculous healings that took place when the disciples preached about the risen Jesus and prayed for the sick and infirm. No one turned to Jesus because of some disciple remaining sick to show patience and fortitude! Many turned

to Jesus because of the healings and miracles He performed on those that were suffering.

Messenger of Satan

2 Corinthians 12:7 clearly shows us what Paul's thorn in the flesh was. It says it was the messenger of Satan. The word messenger appears seven times in the Bible and the word angel appears 181 times. Both words come from the Greek word **angelos**, which means messenger or angel. They can be used interchangeably. Hence we see that the thorn in the flesh was a personality, a demonic angel rather than an eye disease.

Numbers 33:55 sheds more light on the subject. It says that the inhabitants of the land (or other nations) would be pricks in Israel's eyes and thorns in their sides, and would vex them in the land wherein they dwelt if they would not drive them out. They would not physically be pricks in their eyes or physical thorns in their sides, but just like a thorn in the side is an annoyance, the other nations would be an annoyance to the Israelites. Joshua 23:11-13 and 2 Samuel 23:6 both talk about thorns, but both refer to a personality rather than a sickness or disease.

2 Corinthians 12:9 tells us that this messenger of Satan (Paul's thorn) caused "weaknesses" or "infirmities" to come upon Paul. The words weaknesses and infirmities can also be used interchangeably. The Greek word is 'astheneia' according to Thayers Greek-English Lexicon means "weakness and to bear trials and troubles." Once again, it has no reference to sickness or disease. 2 Corinthians 12:9 reads, "and He said to me, 'My (Christ's) grace (which is for the inner man or spirit) is sufficient for you, for My strength is made perfect in weakness (Greek- asthenia).'

Therefore most gladly I will rather boast in my infirmities, that the power of Christ may rest upon me." The weakness mentioned here does not refer to physical weakness, as in sickness, but one's own spiritual weakness. When we realize that in and of ourselves we are weak, but God is strong, then we will see the power of God resting on us. Paul realized that apart from Jesus, he could do nothing (John 15:5).

I do not see anywhere in God's Word where He has called anyone to suffer with sickness or disease. There are times He has called us to suffer. 2 Timothy 2:12 says, "if we suffer with Him (Jesus) we will reign with Him." This is not talking about sickness; it is talking about persecution for standing up for the name of Jesus. 2 Timothy 3:12 says, "all who live godly in Christ shall suffer persecution."

What Did Paul's Thorn Cause?

I have shared with you what Paul's thorn is not and have explained the thorn in the flesh. I want to share with you what Paul's thorn in the flesh caused to happen to him.

2 Corinthians 11:23-30, the verses just before, talking about Paul's thorn, clearly reveals that Paul's thorn in the flesh was a messenger or angel (demon) of Satan that caused Paul to go through beatings, prison, shipwrecks, death, weariness, hunger, thirst, cold, nakedness, painfulness and many other perils. Nowhere does it say that Paul's thorn was an eye disease or sickness. We need to stick to God's word. If it is not in the Word, then do not buy into that belief. That is how false doctrine comes about.

In 2 Corinthians 11:29-30, Paul sums it up by saying, "Who is weak, and I am

not weak? Who is made to stumble, and I do not burn with indignation? If I must boast, I will boast in the things which concern my infirmity." Paul did not glory in sickness. He gloried in that he had to bear trials and troubles while he was taking a stand for Jesus.

Acts 5 talks about the miracles that God did through the apostles as they preached Jesus Christ and the persecution they suffered. Acts 5:41-42 records, "So they departed from the presence of the council, rejoicing that they were counted worthy to suffer shame for His name. And daily in the temple, and in every house, they did not cease teaching and preaching Jesus as the Christ." If you believe you are to suffer for God's glory consider what it is to suffer for Him while out preaching the Gospel of Jesus Christ not with sickness. Suffering with sickness is not what glorifies God. The glory goes to God when we believe in God for a miracle and we receive it. The scriptures are very clear on this.

Isaiah 53:4-5, Matthew 8:16-17 and 1 Peter 2:24 all talk about Christ bearing our sins, griefs, sorrows, sickness, disease and infirmities. If that is true, why are so many Christians thinking they have to bear sickness, infirmities and disease? Was not Christ's suffering and sacrifice enough? It was more than enough! I am going to stand for what Jesus purchased! Jesus Christ paid for it all! It belongs to you. You do not have to suffer with these things to glorify God. Jesus bore our sin, sickness, torment, poverty, and humiliation not with us, but for us! He is not asking us to bear or carry these things. He did it for us. The word borne in Isaiah 53:4 is the Hebrew word nasa, which means "suffered for, bear up, carry off, take away." He did all the suffering so we do not have to. He took the raw deal and we received the good deal. He paid the price in full for spirit, soul and body.



Schizophrenic God? Finding Reality in Conflict, Confusion and Contradiction

Chapter 2 Why All This Confusion?

as the world designed to be so chaotic, confusing, and downright dangerous—or was it made for everything to function in a harmonious, orderly way? Was it originally intended to be a loving and safe environment for all who dwell here?

Some people tell me, "I have a dysfunctional family," and I tell them, "You have a dysfunctional world!"

Let's look at two predominant views. But before we do, let's look at the definition of a few terms. Most people believe that God is sovereign; and of course, if God is God, He is sovereign. The dictionary defines sovereign as "having supreme rank, power, or authority." In other words, He's at the top of the ladder. There is no one above Him. God is also omnipotent, which means He's all-powerful, possessing unlimited power. He's also omnipresent, which simply means He's always present everywhere.

The Extreme Sovereignty View

With those things in mind, let's examine the first worldview, which I call the "extreme sovereignty" view. As we closely look at this view, I will explain why I call it *extreme*. Most people, whether atheists or firm believers, may be shocked to discover that they have parts of this view imbedded in their belief systems.

The extreme sovereignty view reasons that since God is sovereign, omnipotent, and omnipresent, He also exercises *omnicontrol*. In other words, God has predestined and preordered everything that happens in life; whatever happens, God either causes it or allows it as part of His divine plan and will. An event wouldn't have happened unless God willed it, because God exercises omnicontrol. This view says all things are prearranged in the plan of God, and there's a divine reason behind everything that happens in life.

According to this view, God decides the destiny of all human begins and orchestrates all that happens in the world, even the evil. Whatever happens to you in life—period—is God's sovereign will. The ultimate reason behind why everything happens is God. God is the ultimate Why. Things that look "evil" somehow fit into God's overall plan for good; God must have some wise, loving purpose behind them.

This view reasons that if God is good and controls all things, then all things must be good or loving or just. We are to accept them as coming from the loving hand of a God who in His sovereignty has some kind of divine purpose behind it. So when cancers, car wrecks, or divorces occur, people who believe this view give pat answers such as: "There's a purpose for everything. God has His reasons." "His ways are mysterious and past finding


out." "All is still under His control, and remember that God is sovereign."

The word sovereign is not used in the King James Version of the Bible, and when the concept is used, it is never used in the manner in which the extreme sovereignty view defines it. This view leaves people with a passive, "Que sera, sera; whatever will be, will be" attitude about life. This view in its extreme form tells us that all things are of God, so God is behind all things. However, if you see God behind all things, you then see God behind all evil. In effect, you are calling good evil; worse yet, you are calling God evil!

Is it any wonder that so many people are terrified of God and inwardly feel that He has a dark, malicious side to His nature? How can we ever know what God's going to do? This view leaves us in doubt about the nature of God and the will of God because it paints the picture of good and evil coming to us from the hand of the same God. This view leaves people with a big sigh of resignation, and all they can say is, "Well, God is sovereign."

Go with me now on my first trip overseas. I had never been out of the United States, not even to Mexico or Canada. You can imagine the shock that hit me when I arrived in Bombay, India. Millions of people are homeless and sleep every night on the streets of this massive city. I was completely stunned, and I wept for two days

over the scenes that confronted me. Crushing poverty and debilitating diseases made me keenly aware that the earth is filled with horrifying suffering and diabolical evil.

In India, I came face to face with a man whose nose and lips had been eaten off by leprosy. His appearance had taken on the form of part man, part skeleton! I knew from the depths of my soul that it was never God's intention for the love of His heart, the human race, to be trapped in this type of horror-movie existence. This was not the will of an all-loving God.

The Jesus Worldview

With that as a background, let's explore the second worldview, which I will call "the Jesus worldview." The historical character, Jesus of Nazareth, was actually God becoming a human being or "the Word was made flesh" (John 1:14). He was the full revelation or explanation of God (see John 1:18), actually showing us what God is like. He even told one of His followers, "He who has seen Me has seen the Father [God]" (John 14:9 NKJV).

I challenge you to approach Jesus and His worldview as if this is your first time to ever hear about Him. Lay aside all your preconceived notions and notice the character, heart, actions, and will of Jesus of Nazareth as He is so carefully portrayed in the Bible in the Books of Matthew, Mark, Luke, and John.

When Jesus burst upon the scene when He began His ministry, He approached life as if He was entering a war zone! He came to the rescue of a victimized, suffering human race.

Every person He touched, He treated with mercy and compassion. He treated them as if they were casualties of war. Now remember that Jesus is "the exact representation" of God's nature (see Heb. 1:3 NASB). Jesus is "re-presenting" God to the human race. Everything about Jesus represents God exactly (see Heb. 1:3).

Therefore, Jesus is the great Revealer of God to you. He reveals God's heart, God's attitude, and God's desire toward life and the human race. Watch how Jesus approached the brokenhearted, the sick, the suffering, the confused, the guilt-ridden, and the downtrodden, and there you will see the will of God in action. Jesus is the will of God in an earth suit; and when He entered the war zone on planet Earth, He aggressively challenged the disasters and dilemmas of humanity.

Just a little side note here—in my travels around the world, I have noticed that the majority of the people of the world believe that there is a real, invisible spiritual realm that is inhabited by spirit beings. From this spirit realm, things can be determined and set into motion in the physical realm. These parts of the world (India, Asia, Africa, South America) see a steady stream of miraculous occurrences taking place; things happen that cannot be explained by human logic.

In contrast, countries in the West (U.S., Canada, Britain, France, Spain, etc.) believe that the world is all physical and material. This puts us out of step with the vast majority of people groups of the world; and, consequently, we see and experience less of the miraculous.

Is there a realm of spirits, a spiritual realm, or is there not? How would we ever know?

I appeal to Jesus! Throughout this journey you will hear me make that statement. Jesus said that He was "the Truth," or that reality was found in Him (see John 14:6). In a judicial system, there is always a final court of appeal. Jesus' life and words are the supreme court of appeal—the final authority—where all issues about life can be settled.

Here's where the confusion has entered in: people have allowed their logic, opinions, and experiences in life to determine truth for them instead of settling the issue that Jesus knows the truth and tells the truth, and that reality can only be found in Him. If my opinion about matters in life contradicts or doesn't agree with Jesus' words or actions, guess whose opinion is invalid? Mine! I don't have the wisdom, experience, or audacity to say, "Oh, no, Jesus! I'm right, and You're all wrong!"

Let's recap these two contrasting views: Extreme sovereignty worldview—God has predestined or preordered everything that happens in life. God exercises omnicontrol, so you have no choice or will in the matter. If

something happens, God willed it for you. If something fails to happen, it was not His will. Whatever happens in life, God either causes it or allows it as part of His divine will and plan. In this blueprint plan, it is believed that even evil things that happen will somehow bring about good in the end. God's will is the ultimate reason behind every event in life.

Jesus' worldview—Jesus approached the world as if something had terribly gone wrong, "An enemy has done this!" (Matt. 13:28). Jesus does not view everything that has happened as the will of God, but with determination He resolves to reverse the curse of suffering and heartache that has blasted the human race. Jesus brought healing, deliverance, and relief to people, treating them as if they were casualties of war. Jesus' worldview does not show us that everything that happens in life is always God's will; He actually waged war on that which was not God's will by helping the misfortunate out of their predicaments. Jesus' life and worldview clearly show us that there are wills, other than God's will, at work on planet Earth. 🤎
